

## Insights on COVID-19 Crisis Electricity Demand Destruction - Update

This daily update on electricity demand destruction uses data available through 01Jun2020. All results are derived from hourly historical demand as published by the market administrators (NYISO, PJM, MISO, ERCOT and CAISO) and are weather-normalized and de-trended. The demand destruction statistics reported here are in percentage departure from normal given prevailing weather conditions and time-of-year.
