

Insights on COVID-19 Crisis Electricity Demand Destruction - Update

This daily update on electricity demand destruction uses data available through 30Sep2020. All results are derived from hourly historical demand as published by the market administrators (NYISO, PJM, MISO, ERCOT and CAISO) and are weather-normalized and de-trended. The demand destruction statistics reported here are in percentage departure from normal given prevailing weather conditions and time-of-year.

Note: Recent drops in temperatures in the Mid-Atlantic and the NorthEast are reducing residential AC-driven demand, suggesting a return to greater levels of demand destruction in a number of zones, as discussed in our analysis on Page 3.

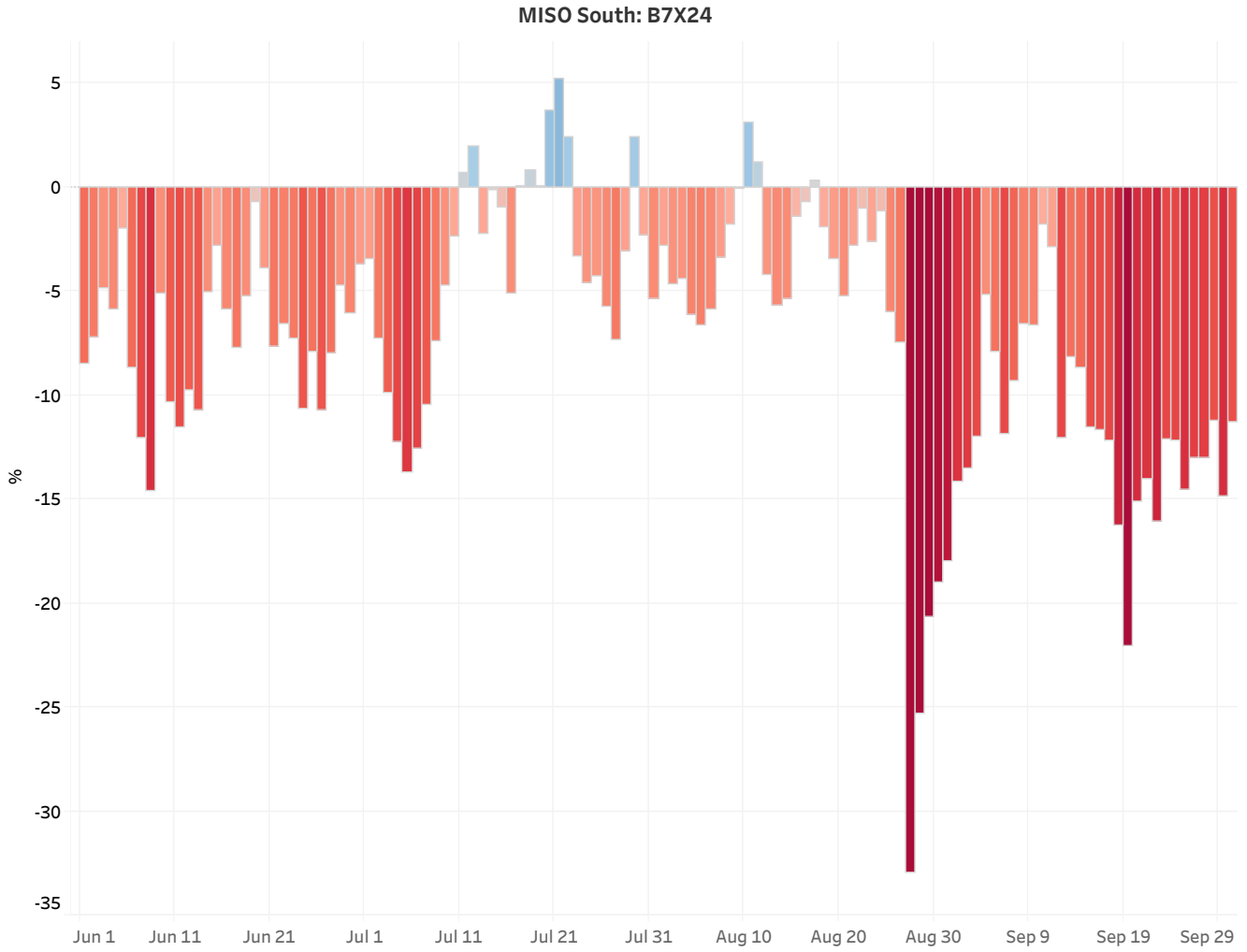

MISO South: Impact of Hurricane Laura and Hurricane Sally

We are continuing to track the impact and rebound from Hurricane Laura and Hurricane Sally. The figure below shows the daily 7X24 load residuals for MISO South which includes Louisiana. Initial demand destruction levels approached 35% and are currently at roughly 11%.

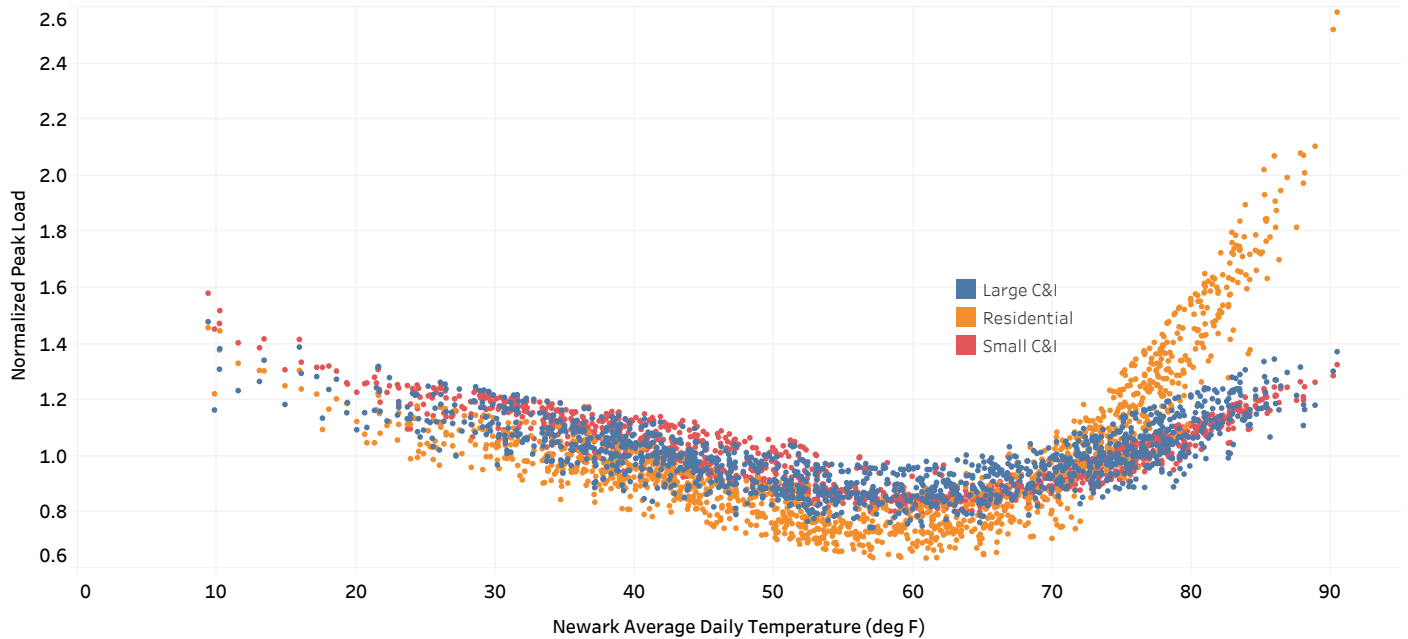


Spurious Seasonal Return to Normal Zonal Usage

Our analysis includes the behavior of PSEG load for three classes of customers: Residential, Small C&I and Large C&I. Zonal loads are aggregates of all sources of electricity demand, with these three being the dominant components. Each of these components also responds differently to variations in temperature. The figure below shows our estimates for these PSEG load groups (normalized by the average load over the historical data sets) versus daily average temperature at Newark. Residential load, as most practitioners would expect, has the largest response to extreme temperatures.

This has important implications for demand destruction statistics at the zonal level. The general increase in residential usage caused by societal response to the COVID-19 pandemic, coupled with relatively greater residential usage at high temperatures, means that zonal loads can exhibit a return to (or at least a trend toward) normal levels even while substantial economic dislocations remain in play. This is currently the case in PSEG and likely pertains broadly across the zonal statistics shown in our report. In the absence of any fundamental change to the COVID-19 landscape, this phenomenon will likely reverse with the approach of autumn.
